Current Federal Changes

Deferred Action for Childhood Arrivals (DACA)

- DACA recipients are no longer eligible for coverage through the marketplace.
- All current DACA enrollees will see their coverage end on September 30.
- BeWell will be notifying these customers on Sep 2nd.

Low-income individuals and households

• New Mexico's special enrollment period for those with household income up to 200% of the federal poverty level (about \$62,400 per year for a family of four) ends October 1, 2025.


