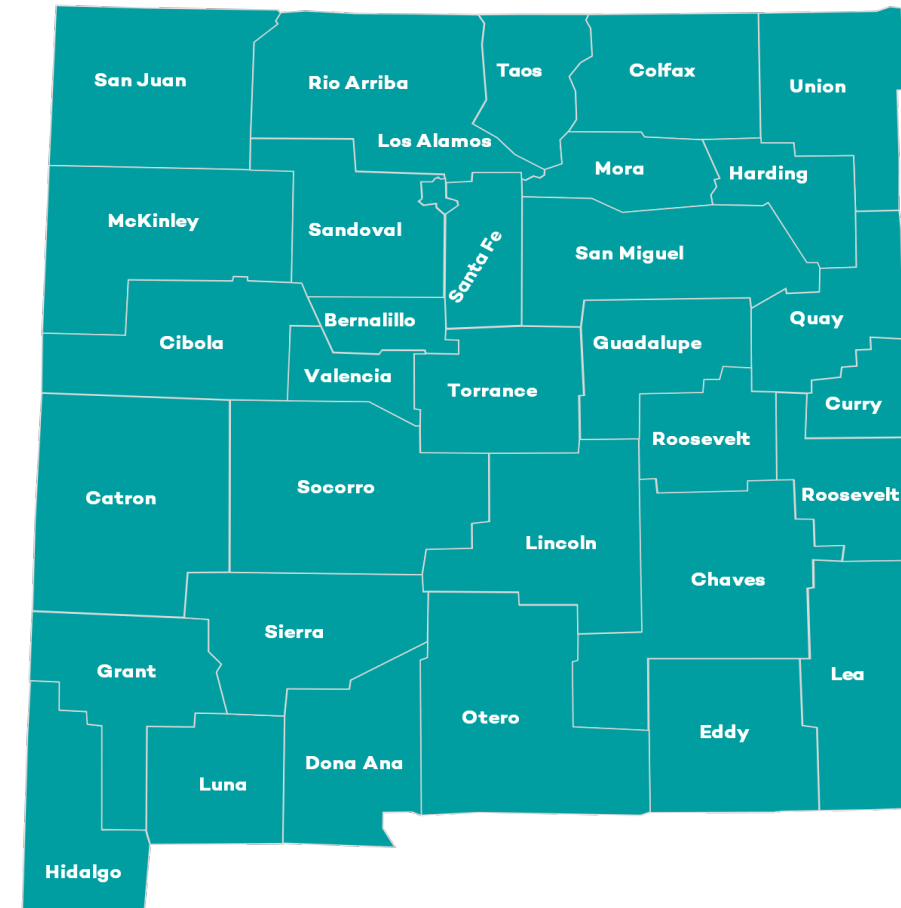

Premium Billing Process



As of Plan Year 2026, **Molina Healthcare of New Mexico** will directly handle premium payments for exchange members. This marks a shift from previous years when **BeWellNM** processed payments.

Binder Payments: Members must make a binder payment before receiving their Member ID card. This typically takes 1–2 business days post-enrollment.

Broker Portal Access: Brokers can view payment status, net due amounts, and paid-thru dates via the Evolve Broker Portal <https://account.evolverxt.com>

Payment Portal: Members can pay via [BillMatrix](https://webpayments.billmatrix.com/MHCInitialPayGuest) without needing a portal login. <https://webpayments.billmatrix.com/MHCInitialPayGuest>
